1. Send your digital photos to Teresa Baldinucci baldiny2@optonline.net All digital photos must be taken at the HIGHEST RESOLUTION POSSIBLE on your digital camera. The digital image must be submitted as a JPEG with 300 pixels per inch resolution and a minimum size of 4" x 6"; (approximately 1200 x 1800 pixels). Low resolution photos will not print well and cannot be used.

2. Even though you email a photo, you **MUST** mail (or scan and email) a signed FCC Long Island Parental Consent and Release (signed by both parents if applicable) and Photographer' s Consent and Release (in the case of professional photographs) . If other release forms are submitted, your photo may not be considered. Group shots must include a signed Release for each child.
